Minutes of the ANNUAL GENERAL MEETING of the Members of West Neighbourhood House held Online and by Telephone on Thursday, June 24, 2021

Present: Sean Hurley, Will Falk, Emily Paradis, Prasad Rao, members of the Board of Directors, Voting Members, Guests, Maureen Fair (Ex-officio), and Tracy Watson (Recording Secretary).

1. WELCOME

Emily Paradis welcomed members and guests for joining **West Neighbourhood House's 2021 Annual General Meeting** and thanked everyone for their participation, for a second time - online, over the phone or by phone networking, because of the COVID-19 pandemic and the need for physical distancing.

As part of the welcome Emily included a Land acknowledgement:

I gratefully and respectfully acknowledge that West Neighbourhood House operates on the traditional territories of the Huron-Wendat, the Chippewa, the Seneca, and the current treaty-holders, the Mississaugas of the Credit. This territory has been the site of human activity since time immemorial, and is today the home of diverse First Nations, Inuit, and Metis peoples, and Indigenous peoples from all over the world. It is governed by the Dish With One Spoon Wampum Belt Covenant, a treaty between the Anishinaabe, Haudenosaunee, and allied nations that bound them to share the territory and protect the land and waters surrounding the Great Lakes. Subsequent Indigenous Nations and peoples, European settlers and all newcomers have been invited into this treaty in the spirit of peace, friendship and respect. Shamefully, the land now known as the City of Toronto was never legally ceded, and was acquired by the British Crown through the fraudulent Toronto Purchase. In entering into the Dish With One Spoon Covenant, we pledge to uphold our responsibilities as treaty people – to share and care for the land, to act in respect and friendship, to be mindful of broken covenants, and to strive to make this right.

2. PRESIDENT'S REMARKS

Emily described being deeply honoured to have been named President of the West Neighbourhood House volunteer Board of Directors this year.

Emily thanked the following individuals:

- Rona Abramovitch who was Board President until May this year. Rona assumed tremendous responsibility as a volunteer leader during the COVID-19 pandemic and during our internal review of anti-Black racism. Rona dedicated hundreds of hours and very thoughtful support to the House during an extremely difficult year.
- Staff of West Neighbourhood House who persevered through this long pandemic, keeping our community served and safe.

• West Neighbourhood House Membership for taking the time so show interest and support for West Neighbourhood House.

3. SIR JAMES WOODS AWARD

Rona explained that every year, West Neighbourhood House honours a volunteer community development leader with the Sir James Woods Award. Sir James Woods was one of the key founders, in 1912, of St. Christopher House, as we used to be known. He believed in people taking greater control in their communities – something the House continues to work on to this day 109 years later.

This past year was an unusual year with many people stepping up to help out in the community. The Sir James Woods Award this year has 3 separate winners deserving our acknowledgement and appreciation.

The three winners of the Sir James Woods Award

4. ANNUAL GENERAL MEETING

Emily Paradis, as Chair of the meeting, explained that the formal part of the Annual General Meeting is one way we show this organization's accountability to the community and that members in attendance have an important role in this organization's governance.

Emily highlighted that the Annual General Meeting is held once a year so that all members of West Neighbourhood House have an opportunity to:

- hear about the House's activities over the past year
- elect or re-elect volunteer Directors to the Board
- approve the financial statements for the year ending March 31, 2021 and the auditor's report
- appoint auditors for next year

5. APPOINTMENT OF SECRETARY

Emily appointed Tracy Watson as Secretary for this Annual General Meeting of the membership and thanked Lambrina in advance.

6. VOTING PROCEDURE/CALL TO ORDER

Emily highlighted that only voting members are eligible to vote on the decisions needed at this meeting and because we have members both on the phone and online, and that we have to do voting differently than if we were all present in one room.

Emily explained that first, she will read the motion and ask for everyone voting for the

motion to say Yes and that she will then pause and ask for everyone voting against the motion to say No and pause again and ask for everyone abstaining from the vote to say Abstain.

Emily called the meeting to order given that quorum of 40 voting members was reached.

7. MINUTES OF LAST MEETING JUNE 25, 2020

Emily confirmed that the minutes of the last Annual General Meeting held on June 25, 2020 enclosed in the AGM package were sent to each registered member and that the minutes were visible on the screen.

Emily called for a voting member who was present at last year's meeting to move that we approve the minutes.

Moved by Prasad Rao that the minutes of the last meeting June 25, 2020 be approved. Seconded by Margaret Pereira. Emily called the vote and the motion carried.

8. FINANCIAL REPORT

Emily called upon our volunteer Board Treasurer, Reilly Latimer, to present the Financial Report.

Reilly presented the Financial Statements and explained that he is referring to the fiscal year which ran from April 1, 2020 to March 31, 2021.

Reilly confirmed that the Board of West Neighbourhood House has a Finance and Audit Committee of volunteers who met with management staff and our Auditors, Grant Thornton, to review the complete financial statements. Reilly reported that Auditors have stated that they have no concerns about the financial management of West Neighbourhood House and that we had a clean audit.

Reilly moved that the audited financial statements and all attached schedules for the year ending March 31, 2021 and the Auditor's Report be approved.

Emily called for someone to second the motion and the motion was seconded by Will Falk. Emily called the vote and the motion carried.

9. THANK YOU

Reilly thanked the audit team from Grant Thornton in the midst of COVID-19 for their professional and courteous service. Reilly also thanked Vathani Vadivel, Director of Finance, and the Finance staff team for their hard work and dedication.

10. APPOINTMENT OF AUDITORS

Reilly expressed how pleased Finance and Audit Committee were with the work of Grant

Thornton as our auditor this year. Reilly moved that Grant Thornton be appointed auditors for 2021/22 at a fee to be fixed by the Board of Directors.

Emily called for someone to second the motion and the motion was seconded by Melanie Newton. Emily called the vote and the motion carried.

11. ELECTIONS TO THE BOARD OF DIRECTORS

Emily invited Sean Hurley, Chair of the Nominating Committee, to present the candidates for election to the Board of Directors.

Sean explained that the Nominating Committee is responsible for recruiting and interviewing potential candidates to the Board of Directors and that the committee looks for diverse skills and life experiences.

On behalf of the Nominating Committee, and as listed in the AGM package mailed to members in advance, Sean proposed the following qualified nominees for election to the Board of Directors:

To be elected for a one-year replacement term (2021 to 2022): Sarah Mencia De Lara

To be elected for a first three-year term (2021 to 2024): Rutendo Change Melanie Newton

To be elected for a second three-year term (2021 to 2024): Will Falk Susan Main Prasad Rao

To be elected for a third one-year term (2021 to 2022): Emily Paradis

Emily called for someone to second the motion and the motion was seconded by Genna Buck. Emily called the vote and the motion carried.

12. SEAN HURLEY (COMMUNITY REPRESENTATIVES FOR THE NOMINATING COMMITTEE)

Sean confirmed that the Nominating Committee consists of several Board members and community members and highlighted that the committee is pleased to have continuity with the following community members recommended for re-election on the Nominating Committee.

On behalf of West Neighbourhood staff and volunteers, Emily wished everyone a safe and healthy year ahead and adjourned the business portion of our Annual General Meeting.

Dorothy Charach
